
NOTICE IS HEREBY GIVEN that at the meeting of the Oversight Board (the "Oversight Board") to the Successor Agency of the South Tahoe Redevelopment Agency (the "Successor Agency") to be held on July 25, 2014, at 3:00 p.m., or as soon thereafter as possible, the Oversight Board will consider the adoption of a resolution to direct the Successor Agency to convey to the City of South Lake Tahoe (the "City") for governmental use properties pursuant to the Successor Agency's Long Range Property Management Plan. The Long Range Property Management Plan has been previously approved by the Oversight Board and the California State Department of Finance. The property is located in the City of South Lake Tahoe

Interested persons are invited to attend this meeting and be heard regarding this matter. An individual who challenges any decision regarding the proposed actions in court may be limited to raising only those issues such individual or someone else raised at the meeting described in this notice or in written correspondence delivered to the Oversight Board at, or prior to, the meeting. Due to the time constraints and the number of persons wishing to give oral testimony, time restrictions may be placed on oral testimony at the meeting regarding the proposal. Any interested person may wish to make comments in writing to assure that the relevant views are expressed adequately. Written comments may be submitted to the Oversight Board prior to the time set for the meeting, to the attention of the Secretary of the Oversight Board at South Lake Tahoe, California.
