South Lake Tahoe, CA (April 5, 2018) – At Tuesday’s City Council meeting, City Council requested the City Clerk proceed in soliciting applications for two (2) appointments to the City Planning Commission to fill a vacancy.

The Planning Commission assists in the preparation, update of and recommendations to the City Council concerning the general plan for the physical development of the City; performs those duties set forth in Article 7 of the California Government Code under such conditions as the City Council may from time to time establish; and also serves as the Delinquent Refuse Hearing Board.

Commission meetings are generally held on the second Thursday of each month at 3pm in the City Council Chambers. The term will expire in January, 2019 and applicants must reside within the City Limits.
