- Application Fee
- Site map and photographs showing location of the proposed art installation
- Conceptual design including detailed drawings showing materials, color, and dimensions as well as specific information about the installation including interface with building architecture, landscape, or other construction elements of the proposal if applicable
- Provide 1 to 3 images of other works created by the artist in the proposed medium, which demonstrates the artist personal style
- Written statement about the installation demonstrating consistency with the following findings:
 - Art shall be consistent with the mission, vision, and core values of the Art, Culture and Tourism Commission
 - Art shall be consistent with the mission, vision, and values of the City Strategic Plan
 - Art pieces must provide unique context that does not duplicate other works of art
 - Art must exhibit good craftsmanship and be able to withstand the stresses of the mountain environment
 - Art shall not be construed as signage through means of any character, letter, figure, symbol, model or device or combination of these used to attract attention or convey a message and which is readable from a public street, public recreation area, bicycle trail or from Lake Tahoe
